3.2 Integrity Complaints

SUBJECT / ISSUE

Sport Integrity Australia manages Complaints about Child Safeguarding and Discrimination for sports that are operating under the National Integrity Framework (NIF).

WHAT IS THE STORY TO TELL/KEY POINTS?

- Since Sport Integrity Australia opened in July 2020, we have received over 1300 non-doping integrity matters and made over 170 referrals to law enforcement.
- Following a review into the NIF in early 2023, SIA now focusses our complaint management resources on the most serious and high-risk matters, being safeguarding children and young people and discrimination.
- Sports manage complaints about all other matters, including member protection issues between adults, selection issues, and competition manipulation issues. SIA provides education, training and support to help them manage complaints on these issues, and frequently provides advice to NSOs on individual matters.
- The Integrity Complaints team receives (on average) around 40 new NIF matters per month and has around 70-80 open matters at any given time.
- Around 30% of open NIF matters are under investigation. The remainder are under evaluation or are being managed through education (Category 1 process). Some are also on hold pending action from law enforcement.
- While we cannot manage their Complaints, Sport Integrity Australia continues to support non-NIF sports through other capability building mechanisms such as the Safeguarding in Sport Continuous Improvement Program.
 - We will also assist to refer any non-NIF integrity matter to law enforcement and connect reporters with the sport and wellbeing support where required.

KEY STATISTICS

Since the stand up of the Complaints framework, we have:

- Finalised over 50 NIF Investigations.
- Educated over 40 sport participants through the Category 1 process.
- Substantiated over 55 breaches of integrity policies.
- We receive 40+ new NIF matters a month
- We have around 70-80 open matters at any given time
- We have received over 1300 non-doping matters since July 2020
- We have made more than 170 law enforcement referrals since July 2020

Sanction examples

Sport Integrity Australia has developed guidance to support sport in making proportionate sanction decisions. Sport Integrity Australia's findings and/or sanction decisions made by the sport can be appealed, including through the National Sports Tribunal.

Recent sanction handed down by sports following a Sport Integrity Australia investigation include:

• For two respondents **S** 38 that were found to have engaged in emotional and psychological abuse of another athlete **S** 38

- Respondent A had one allegation substantiated that resulted in a <u>5 38</u> suspension from all national level activities, mandatory education and counselling and supervision during club activities.
- Respondent B had three allegations substantiated that resulted in an <u>S 38</u> from all national level activities, mandatory education and counselling and supervision during club activities.
- Another sport determined the following sanctions for an adult male coach who was found to have breached the Child Safe Practices, relating to sexual misconduct, professional boundaries and use of electronic or online communications.
 - Six specific allegations were substantiated and resulted in a 2-year suspension from all sporting activities, upon return a 1-year good behaviour period and mandatory education in child safeguarding.

Drafting note – these two sanctions are currently under appeal through the NST. Update to brief may be required once outcomes are known (hopefully mid-October).

2023 STATISTICS (YTD - 31 AUGUST 2023)

Between 1 January and 31 August 2023, SIA received 394 integrity submissions, of which:

- 342 related to a NIF sport
- 52 related to a non-NIF sport
- 282 were Reports and
- 112 were formal Complaints
- 70 matters were referred to government, law enforcement, sporting or doping organisations.

3.5 Integrity Complaints

SUBJECT / ISSUE

Sport Integrity Australia manages Complaints about Child Safeguarding and Discrimination for sports (n=83) that are operating under the National Integrity Framework (NIF).

These are often the most serious and high-risk Complaints - independence is crucial.

WHAT IS THE STORY TO TELL/KEY POINTS?

- In 2022, we saw an increase in integrity matters received as more sports adopted the NIF.
- In 2022, approximately 95% of submissions evaluated under the NIF related to child safeguarding and/or member protection issues.
- From 1 January 30 April 2023, we received 184 non-doping submissions.
 - o We currently have around 80 open (non-doping) integrity matters (NIF+non-NIF).
 - Note for Exec: Revised communications about our remit from 1 February 2023 will result in a reduction of 'other' integrity matters being reported to us, so this year's data is not going to be comparable to last years. Child Safeguarding has, and will, continue to form the majority of matters going forward.
- Since the formation of SIA (1 July 2020 to 30 April 2023) over 290 integrity matters (not including doping) have been referred to an external partner, the majority going to law enforcement (over 170).] The matters referred to law enforcement covered:
 - Child Safeguarding 63.2 %
 - Member Protection 17.5%
 - Competition Manipulation 6.2%
 - Improper Use of Drugs and Medicine 4.5%
 - o Other 8.5%
- Since the commencement of the NIF (31 March 2021 to 30 April 2023) SIA has finalised 35 NIF Investigations.
 - Note for Exec: Any request for a breakdown of investigations should be taken on notice so we can consider the release of operational information.

STATISTICS - 12-MONTH TREND (2022)

Between 1 January and 31 December 2022, we received **499** non-doping submissions that alleged breaches of integrity policies.

- 347 of these related to NIF sports, the submission types were:
 - 247 Complaints (Formal Complaints to actioning under the NIF), and
 - 100 Reports (submitted anonymously or provided for information only not eligible to be a Complaint).

- Within these submissions there were 449 separate allegations:
 - **113 allegations** related to child safeguarding, with just over half of these alleging poor behaviour by a coach
 - 222 allegations related to member protection
 - 17 allegations related to competition manipulation
 - 4 allegations related to the improper use of drugs and medicine
 - 87 allegations related to the National Integrity Framework Policy
 - 6 allegations related to other policies

These are often the most serious and high-risk Complaints - independence is crucial.

WHAT IS THE STORY TO TELL/KEY POINTS

- Over 90% of submissions evaluated under the National Integrity Framework related to child safeguarding and/or member protection issues.
- From 1 January 30 April 2023, we received ¥184 non-doping submissions.
 - We currently have around 7580 open (non-doping) integrity matters (NIF+non-NIF).
 - Note for Exec: Revised communications about our remit from 1 February 2023 will result in a reduction of 'other' integrity matters being reported to us, so this year's data is not going to be comparable to last years. Child Safeguarding has, and will, continue to form the majority of matters going forward.
 - Since the formation of SIA (<u>1 July 2020</u> to 30 April 2023) <u>XXover 160</u> integrity matters (not including doping) have been referred to <u>an external partner, including</u> law enforcement.
- Since the commencement of the NIF (31 March 2021 to 30 April 2023) SIA has finalised X35 NIF Investigations.

STATISTICS

Between 1 January and 31 December 2022, we received 499 non-doping submissions relating to alleged breaches of integrity policies. 347 of these submissions related to sports that have implemented the National Integrity Framework, with the type of submissions received being:



2.10perations - high level overview

SUBJECT / ISSUE

This brief provides statistics on integrity matters received by SIA in 2023.

WHAT IS THE STORY TO TELL/KEY POINTS?

- Our aim is safe and fair sport at all levels, for all participants.
- Everyone should be able to participate in sport.
- We are working to change behaviours and the culture of sport by coordinating a national approach to matters relating to sports integrity in Australia. Our National Integrity Framework (NIF) means sports have consistent policies for the first time. (87 Sports).
- Child protection is the biggest challenge, children and young people remain vulnerable in sport.

Integrity Complaints

- We manage child safeguarding and discrimination Complaints and Reports on behalf of NIF sports.
- We undertake investigations to consider whether a breach of an integrity policy has occurred. A number of sport participants have had their memberships suspended for 12+ months following substantiated breaches of integrity policies.
 - One sport participant (coach) had their membership permanently terminated by the sport as a result of a Sport Integrity Australia investigation.
- The most common types of behaviour being reported related to coaches crossing professional boundaries with athletes under the age of 18 (spending time or talking online socially outside of/unrelated to sport events) and inappropriate use of tone and language.
- Athlete to athlete verbal abuse and bullying was also commonly reported
- Sport Integrity Australia leverages key external relationships to support the Complaint Process this includes state and territory police and eSafety.
- The sport's National Integrity Manager (NIM) network also play a crucial role in information sharing to support the Complaints Process.
- Sports manage complaints about all other matters, including member protection issues between adults, selection issues, and competition manipulation issues. Sport Integrity Australia provides resources, training and support to help them manage complaints about these issues, including advice about individual matters.
- While we cannot manage their Complaints, Sport Integrity Australia continues to support non-NIF sports through other capability building mechanisms such as the Safeguarding in Sport Continuous Improvement Program (SISCIP).
- We will also assist to refer any non-NIF integrity matter to law enforcement and connect reporters with the sport and wellbeing support where required.

Anti-Doping

- We are Australia's National Anti-Doping Organisation. As an anti-doping agency, our main responsibility is to implement the World Anti-Doping Code in Australia, thereby protecting the health of Australian athletes and the integrity of sport.
- We achieve this through an informed and innovative anti-doping program encompassing testing, intelligence and investigations, engagement and education.
- We use various levers available to us to conduct deterrence, detection, disruption and enforcement activities, while collaborating with our partners and the sporting community
- Our anti-doping program is consistent with international requirements and Australian legislation.
- We prioritise continuous improvement and innovation in the way we deliver our anti-doping program to keep athletes safe, introducing new processes and capabilities and finding creative ways to engage with and educate athletes
- We will continue to support the athlete voice and educate the Australian sporting community.
- We are required to implement an informed testing program on athletes we have authority over. The testing program needs to be proportionate to the risk of doping and aims to:
 - deter the use of prohibited substances and methods. 0 detect the presence/use of prohibited substances or methods. 0
 - We are committed to working in partnership to strengthen the Australian sporting ecosystem. We

BACKGROUND

Anti-Doping – Tip Offs

- Tip Offs remain consistent across the period. S 38 continues to be the sport subject of the greatest number of tip offs.
- Tip Offs in general continue to be of a low value quality, predominantly anonymous and often infer doping based on increased athlete performance as opposed to any specific information indicating doping. This is particularly prevalent in Signature available.
- Sport Integrity Australia is seeking to uplift its intelligence capability to move towards more proactive intelligence collection methodology to attempt to address the low value quality of the information currently received.
- This information, along with statistics from non-doping integrity issues, are being used as one factor in determining the most appropriate sports to begin with for our Sport Integrity Threat Assessment process.

Anti-Doping - Investigations

- Investigations regarding AAFs across the period have identified continued issues regarding prohibited substances being obtained by athletes being a completely different prohibited substance to what they thought they were purchasing or being contaminated with other prohibited substances.
- We have also seen a continued trend within investigations regarding athletes claiming to have been contaminated, particularly with SARMs, through the use of prohibited substances by people within their close environment (family members/flatmates)
- Information provided through the investigation of AAFs through the period has been able to be provided to law enforcement and other regulators (TGA, AHPRA) which has resulted in criminal charges and compliance actions on those who facilitate the supply of prohibited substances.

Anti-Doping - Disclosure Notices

 Disclosure Notices in general continue to be a useful tool in the investigation of doping violations for matters involving positive tests. s 471



 Internationally we are seeing several International Federations (5.38) (a) who have moved to include a similar style of disclosure process into their policies but support it with a sanction for noncompliance that would be similar to that received for a doping violation.


